

2011-12 North Country Region Application for Tournament Sanction

- SANCTION FEE:** For all tournaments not run by North Country Region
- Short (1/2 day, no playoffs) tournament – \$3 per team
 - Long (full day, with playoffs) tournament – \$5 per team
 - Multi-day (more than one day) tournament – \$8 per team

Tournament directors are **REQUIRED** to provide our Junior Girl's Coordinator, Sue Murphy with a list of teams along with a copy of the playing schedule **at least** one week prior to their event to verify the teams' registration. Sanction fees are due in the region office within 14 days following the tournament unless a different date is agreed upon by the region office and tournament director. Failure to fulfill the above requirements will result in a \$25 fine per date listed on our schedule and future events may not be sanctioned. All sanction fees must be received by June 22, 2012 or there will be an additional fine of \$250. Any event allowing non-USAV teams to participate without NCR approval will be fined \$100. Any event that does not follow their posted information without contacting our office first will be fined \$100!

NOTE: North Country Region will not sanction any other event (scrimmage, tournament or power league) on the weekend of the Presidents' Day Festival (Feb. 18-19, 2012) and the NCR Area Championships (April 28-29, 2012).
