

**2009-10 North Country Region Application for Tournament Sanction**

- SANCTION FEE:** For all tournaments not run by North Country Region
- Short (1/2 day, no playoffs) tournament – \$3 per team
  - Long (full day, with playoffs) tournament – \$5 per team
  - Multi-day (more than one day) tournament – \$8 per team

**Tournament directors are REQUIRED to provide Sue Murphy with a list of teams along with a copy of the playing schedule at least one week prior to their event to verify the teams' registration. Sanction fees and all results are due in the region office within 14 days following the tournament unless a different date is agreed upon by the region office and tournament director. Failure to fulfill the above requirements will result in a \$25 fine per date listed on our schedule and future events may not be sanctioned. All sanction fees must be received by June 25, 2010 or there will be an additional fine of \$250! Any event allowing non-USAV teams to participate without NCR approval will be fined \$100! Use the Tournament Sanction Report form for results and sanction payment.**

**NOTE:** North Country Region will not sanction any other event (scrimmage, tournament or power league) on the weekend of the Presidents' Day Festival (Feb. 13-14, 2010) and the NCR Area Event (April 24-25, 2010).
