Directions

☑Going north on Highway 100: Take 36th Avenue North exit. Turn left onto 36th Avenue North. Turn right on Douglas Drive. Take Douglas Drive to 48th Avenue North where Community Center is on the right.

☑Going south on Highway 100: Take 36th Avenue North exit. Turn right onto 36th Avenue North. Turn right on Douglas Drive. Take Douglas Drive to 48th Avenue North where Community center is on the right.

☑Going north on Highway 169: Take Rockford Road East exit. Proceed east on Rockford Road (which changes its name to 42nd Avenue North) to Douglas Drive. Turn left on Douglas Drive and proceed to 48th Avenue North where Community Center is on the right.

☑Going south on Highway 81: Turn right on County Road 10 (also known as Bass Lake Road) and proceed to the second traffic light. Turn left onto West Broadway and proceed to the second traffic light (again). Turn right onto Douglas Drive and proceed to 48th Avenue North where the Community Center is on the left.

☑Going south on 169: Take County Road 10 (also known as Bass Lake Road) exit. Turn left onto Bass Lake Road and proceed to West Broadway. Turn right onto West Broadway and proceed to the second traffic light. Turn right onto Douglas Drive and proceed to 48th Avenue North where the Community Center is on the left.

☑Going west on Interstate 694: Take County Road 81 exit and go south to County 10 (also known as Bass Lake Road). Turn right on County Road 10 and proceed to the second traffic light (West Broadway). Turn left on West Broadway and proceed to the second traffic light (Douglas Drive). Turn right onto Douglas Drive and proceed to 48th Avenue North where the Community Center is on the left.

☑Going east on County Road 10 (also known as Bass Lake Road): Turn right on Broadway. Proceed to the second traffic light and turn right onto Douglas Drive. Proceed to 48th Avenue North where Community Center is on the left.

☑Going east on County Road 9 (also known as Rockford Road or 42nd Avenue North): Turn left on Douglas Drive and proceed to 48th Avenue North where the Community Center is on the right.
