PROCEDURE TO SUBMIT APPLICATION FOR EVENT SANCTION

Please fill out the application form completely for **each date** you wish to have an event; if the form is not complete, it will delay the process of sanctioning your event. **Once approved**, your event will be listed on the Junior Boys Schedule on the North Country Region (NCR) website. There will be no exceptions to this procedure.

To have your event listed on the NCR Junior Boys Event Schedule, return the completed application form to:

REQUIREMENTS

1. Event Directors must implement their event exactly as approved by NCR on their Application for Event Sanction form for that event. If changes are needed to any of the approved and posted information, please contact Mike Hullerus for approval and to make changes.
2. All teams participating in NCR sanctioned events **must** be a member of one of USA Volleyball Regions; ie. North Country Region. In addition, all Event Directors **must** be a member of North Country Region.
3. Event Directors offering 1-2 events, will receive an invoice reflecting sanction fees due at the conclusion of their event(s). Sanction fees are due within 7 days of the completion of each event unless a different date is approved by NCR.
4. For Event Directors whom are offering multiple events (3+), all sanctioning fees will be due in full to NCR no later than, **June 12th, 2017**.
5. Event Directors will be required to contact Mike Hullerus with a list of teams, along with a copy of the playing schedule for all sanctioned events at least 7-10 days before the event. Team lists and schedules can be sent to Mike at:

6. NCR requests that site directors and court supervisors not participate as a coach or player while running sanctioned events.
7. Please contact Mike Hullerus when your event is full, or if the event is cancelled, so it can be marked as such on the schedule.

FAILURE TO FOLLOW REQUIREMENTS

1. Failure to fulfill requirement #1 above, will result in a \$100 fine. Specifically, any event that does not implement their event exactly as approved by NCR on their Application for Event Sanction form for that event, without contacting NCR first, will be fined \$100.
2. Failure to fulfill requirement #2 above, will result in a \$100 fine. Specifically, any event allowing teams that are not registered with USA Volleyball Region, to participate will be fined \$100.

3. Failure to fulfill requirement #3 above, will result in a \$25 fine per date listed on the NCR schedule and future events may not be sanctioned.
4. Failure to fulfill requirement #4 above, will result in a \$250 fine in addition to the funds due for sanctioning.

SANCTION FEES

Short (1/2 day, no playoffs) event – \$3 per team

Long (full day, with playoffs) event – \$5 per team

Multi-Day (more than one-day) event– \$8 per team

DATES NOT AVAILABLE FOR SANCTIONED EVENTS TOURNAMENTS, SCRIMMAGES, POWER LEAGUES

1. 2017 North Country Region Presidents' Day Festival

- a. Feb. 12 for all ages

2. 2017 North Country Region Area Championships

- a. April 29 for all ages

SUGGESTED EVENT FORMATS

1. Play Day

- a. 3 team pools- play three sets to 25 points, win by two points, no playoffs pool play only
- b. 4 team pools- play two sets to 25 points and a third set to 15 points, win by two in all cases, no playoffs just pool play

2. Tournaments

a. Pool Play

- 1) 3 team pools- play three sets to 25 points, win by two points, determine pool finish based on total set wins and loses
- 2) 4 team pools- play matches two out of three sets, the first two sets to 25 points and the third set, if needed, to 15 points, win by two points in all sets, base pool finish on match wins and loses

b. Playoffs

- 1) Formats to be determined by the tournament directors

3. Warm-up Procedure

a. Events MUST use one of the following procedures when hosting a NCR Event!

- 1) 10 minute (2-4-4); 2 minute share – 4 minute serving team – 4 minute receiving team
- 2) 8 minute (2-3-3); 2 minute share – 3 minute serving team – 3 minute receiving team
- 3) 6 minute (2-2-2); 2 minute share – 2 minute serving team – 2 minute receiving team
- 4) 5 minute (1-2-2); 1 minute share – 2 minute serving team – 2 minute receiving team
